Thank you for your interest in joining the Electoral Roll of our church. In the Church of England the Electoral Roll (as distinct from the civic Register of Electors) is key to the democratic aspect of how we govern ourselves.

There's an old joke that church is like a helicopter - because of the danger of being drawn into the rotas! Well, being on the Electoral Roll does not mean you are signing up to any new commitments and you may in any case already be committed to supporting our church as a volunteer, for which I thank you.

Being on the Electoral Roll means that you can attend and vote at the Annual Parochial Church Meeting (APCM) at which the Annual Reports are presented, questions raised from the floor, our vision for the church reviewed and our performance assessed. It entitles you to stand for election to the Parochial Church Council which, together with the Vicar and Churchwardens, forms our church's leadership. It also entitles you to stand for Deanery Synod, the local tier of church government.

I hope you will find the Electoral Roll application form overleaf easy to complete with the notes provided. On the back page you will also find a Standing Order form should you wish to support our church with a regular financial donation as well as with your time and talents. If you are a UK tax payer, please do also complete the Gift Aid section of the form as this increases the value of your donation by 25% at absolutely no additional cost to you. Please do prayerfully consider supporting our church financially by Standing Order (if you do not do so already) as it really is essential to our church's current viability and future sustainability.

Notes for completing the Electoral Roll form (see overleaf)

- 1. The only Churches at present in communion with the Church of England are other Anglican Churches and certain foreign Churches.
- 2. Membership of the Electoral Roll is also open to members in good standing of a Church not in communion with the Church of England which subscribes to the doctrine of the Holy Trinity where those members are also prepared to declare themselves to be members of the Church of England.
- 3. Every six years a new roll is prepared and those on the previous roll are informed so that they can re-apply. If you are not resident in the parish but were on the roll as an habitual worshipper and have been prevented by sickness or absence or other essential reason from worshipping for the past six months, you may write "would" before "have habitually attended" on the form and add "but was prevented from doing so because..." and then state the reason.
- 4. If you have any problems over this form, please approach the clergy or lay people responsible for the parish, who will be pleased to help you.
- 5. In this form "parish" means ecclesiastical parish.
